Judgment

The entrants will be blind reviewed. The panel of juries will consist of five members, in which two will be from the host country and the other three will be representatives from IFLA

Competition Rules

1. Participation in the competition requires uncondition acceptance of the rules. The competition guidelines and rules should be issued to all schools of landscape architecture through IFLA publications and AFFILIATE MEMBER
2. All competition entries are property of the 44th IFLA World Congress. Entries will not be return to the authors
3. The works submitted by competition entrants will be places on exhibition for the duration of the 44th IFLA World Congress
4. The 44th IFLA World Congress retains a right of duplication and publication of any or all materials submitted to the competition, and there shall be no obligation whatsoever to the entrants, beyond acknowledging the authorship of the works exhibited or published.
5. Submission packages received after the deadline date will not be admitted regardless of their postmark date
6. All postage and delivery charges are the responsibility of the entrants. The 44th IFLA world congress will not be responsible for customs or related fees. C.O.D. shipments will not be accepted
7. All entrants are absolutely forbidden to have their submission (or any part thereof) published in any way prior to notification of the jury's final decision.
8. The jury shall preside over the competition, and is the sole arbiter at all levels until the final attribution of prizes. All decisions of the jury are final
9. The winner of the 44th IFLA World Congress student competition shall be announce by the IFLA President upon the recommendation of the jury
10. All disputes related to the competition that cannot be referred either to the work of jury or to the attribution of prizes shall be settled through arbitration by the 44th IFLA World Congress Executive Committee, who shall appoint arbitration tribunal to settle any disputes
11. Entrants are forbidden from requesting any information from members of the jury

Submission Requirements

All the entrants must submit their materials in CD and prints .

1. The disc should contain a presentation ready for immediate screen viewing; PDF as 4 PDF's of no larger than a total of 50 megabytes /power point presentation. Please label the CD with you name, school name and project title.
2. An A1 (90 x 120 cm) print of the project firmly mounted on board, or other stiff lightweight mounting boards. Which shall be divided into four smaller (45 x 60 cm) panels for mailing convenience .
3. The Board PDF's shall not identify names, faculty sponsors or school teams.
4. The names, faculty sponsors and school of teams shall be put on different file on PDF
5. The entrants must submit a brief of the projects addressing project context, issues to be addressed, main features & innovations. (Maximum 350 words).
6. Entrants who submit prints and 3-dimensional objects will be disqualified
7. The submission can be in any language but the entrants must submit the translation in English.
8. All work is to be submitted anonymously together with an opaque sealed envelope. The opaque envelope must be firmly sealed and shall contain the completed Student Declaration Form.
